Shells/targets – A complete inventory was taken. 96,000 targets will be needed for the summer trap league, so more will be ordered. Half of the load will be standard targets and the other half specialty targets. The cost is up \$1.30 per case from last year. 200 plus cases of shells are on hand.

Hall reservations – 3 inquiries were received regarding rental information.

Clubhouse and grounds – Nothing to report.

Newsletter/memberships – 482 members at present. Get newsletter articles to member Donna Polzin. Facebook/Media/Website - Gary Ross Jr. has installed and programmed an electronic message board in the clubhouse. The website is regularly updated and has received a 29% increase in views from the past, with the calendar, banquet and winter trap league receiving the most looks. He will be looking for summer photos to keep that portion up to date. Vicki Konen is handling Facebook.
