Communications

- A donation request was received from the WI. Sheriffs Association. Motion by Schepp, second by Thoma to donate \$50.00. Motion carried.
- A donation request was received from the Bugle Mouth Bass Association. Motion by Thoma, second by Gozinski to donate a gift box. Motion carried.
- A donation request was received from Norton's Dry Dock for their youth fishing event. Motion by Moderow, second by Gozinski, to donate the same as in 2021. Motion carried.

• Forms were received from the Town of Berlin for Operators License for the club and individuals. The forms were distributed to all those interested in obtaining a bartender license.

Committee Reports

- **Pheasant farm** 1700 birds have been ordered. The food cost is rising.
- **Targets & shells** Konen took an inventory. Trap targets are adequate, some specialty targets are needed. We may partner with the Princeton Club to order a complete truck load. Some shells from the past order have not arrived.
- Youth shooting 72 persons are participating in the Central WI. Youth Trap League.
- **Banquet** A financial report was included with the Treasurer's report. A final meeting is set for Monday, April 18th, at 6:00pm.
- **Rifle ranges** An incident regarding the use of a metal target was received. Polzin handled it. A discussion took place regarding the checking of shooters for membership cards.
- **Tuesday shooting** Trap, skeet, and 5-stand shooting will start tomorrow.
- **Winter archery** Finished.
- Winter Trap league Finished.
- **Hall reservations** Nothing new.
- **Clubhouse & grounds** 2 trees over-hanging the shelter building will be removed when it dries and then the roof will be replaced. Deeper and wider kitchen sinks were suggested. New Nesco cooking units have been purchased. The club and the Target Terminators will split the cost.
- **Newsletter & memberships** 643 members at present with 84 coming from the rifle range. Newsletter articles are due 4/20/22.
- Media & Website & Facebook All are updated as needed.

Old Business

- 1. Trap field lighting: One company responded to Moderow regarding pricing. They specialize in trap field lighting. After a lengthy explanation and discussion, a motion by Gozinski, second by Thoma, to replace the existing lights on trap fields 2, 3, and 4 with the new system. Motion carried. There will be "Focus on Energy" money available from the power company and there is a \$1,200.00 grant from WI. Trap Shooters Association to be used for the project.
- 2. Speaker repair: There are issues in the octagon building. Schepp will look into it.
- 3. Sale of old target release units: They were advertised on a Buy & Sell group for that type of equipment. \$2,200.00 was received for all units which was a comparable price to others on the site.

New Business

- A. The old super star trap target machine is not used and been in storage many years. Motion by Polzin, second by Schepp, to try to sell it for \$2,000.00. Motion carried.
- B. D. Konen will be starting Monday shooting. 3-D archery may also have a league on the same night. Details are taking place.
- C. Member, Jeff Gropp, questioned the procedure for voting at the bi-annual membership meeting. Apparently, a typographic error occurred preventing him from voting.

- The trap scoring bench umbrellas are in poor condition. Thom will look for new ones.

Gozinski: New portable target machine covers are in poor shape. Motion by Schepp, second by A. Konen, to spend \$1,000.00 on covers. Motion carried.
