#### COMMUNICATONS

#### COMMITTEE REPORTS

- 1- Pheasant farm = A written report was given. The loss of birds was 13.8% as a result of a power outage and a breach in the fence. The new caretaker is moving in and a lease was given. He painted the living room. A work day is needed to clean up after the old caretaker.
- 2- Shells/targets = A target order was placed some time ago.
- 3- Ranges = The target netting on the pistol range will be replaced.
- 4- Rentals = Nothing is scheduled.
- 5- Grounds/clubhouse = The bar area floor was refinished to match the hall. A cleaner will be contacted to clean up the dust.
